

Terms of Service:

The following terms and conditions govern all use of the travisbarker.com website and all content, services and products available at or through the website (taken together, the Website). The Website is owned and operated by Travis Barker ("Travis Barker"). The Website is offered subject to your acceptance without modification of all of the terms and conditions contained herein and all other operating rules, policies (including, without limitation, Travis Barker Privacy Policy) and procedures that may be published from time to time on this Site by Travis Barker (collectively, the "Agreement").

Please read this Agreement carefully before accessing or using the Website. By accessing or using any part of the web site, you agree to become bound by the terms and conditions of this agreement. If you do not agree to all the terms and conditions of this agreement, then you may not access the Website or use any services. If these terms and conditions are considered an offer by Travis Barker, acceptance is expressly limited to these terms. The Website is available only to individuals who are at least 13 years old.

1. Your travisbarker.com Account and Site. 3. Payment and Renewal.

- **General Terms.**

Subscription payments will be charged on a pre-pay basis on the day you sign up for an Upgrade and will cover the use of that service for a

monthly or annual subscription period as indicated. Payments are not refundable.

- Automatic Renewal. Unless you notify Travis Barker before the end of the applicable subscription period that you want to cancel a subscription, your subscription will automatically renew and you authorize us to collect the then-applicable annual or monthly subscription fee for such subscription (as well as any taxes) using any credit card or other payment mechanism we have on record for you. "Priority" means that support takes priority over support for users of the standard or free travisbarker.com services. The prevailing party in any action or proceeding to enforce this Agreement shall be entitled to costs and attorneys' fees. If any part of this Agreement is held invalid or unenforceable, that part will be construed to reflect the parties' original intent, and the remaining portions will remain in full force and effect. A waiver by either party of any term or condition of this Agreement or any breach thereof, in any one instance, will not waive such term or condition or any subsequent breach thereof. You may assign your rights under this Agreement to any party that consents to, and agrees to be bound by, its terms and conditions; Travis Barker may assign its rights under this Agreement without condition. This Agreement will be binding upon and will inure to the benefit of the parties, their successors and permitted assigns.
